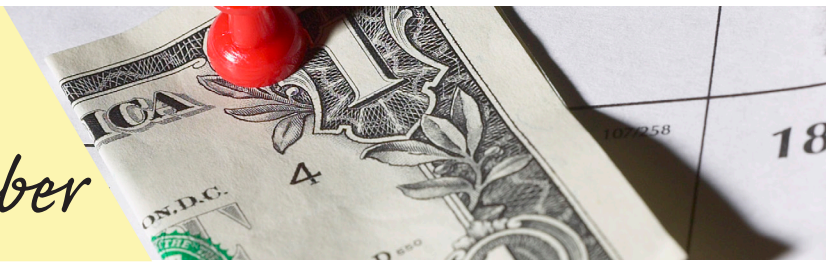

MAY 24 BOOK VOUCHERS BEGIN

JUN. 3 1ST DAY OF SUMMER TERM FOR MOST STUDENTS

JUN. 14 DATE OF RECORD* *Summer semester financial aid will be adjusted based on the number of credits student is enrolled in on this date.*

JUN. 27 BOOK VOUCHERS END

JUL. 8 JAN–DEC WELDING STUDENTS: FIRST DAY OF SECOND TERM

JUL. 18 DISBURSEMENT *of Grants & Federal Direct Subsidized and Unsubsidized loans for most students.*

DROP/ADD is end of the first week of school.

* **THE PAYMENT OF FINANCIAL AID** is based on the number of credits enrolled as of the date of record. If you add any classes after the date of record, your financial aid eligibility will not increase. If you are on a waiting list for a class, then you must be off the waiting list and registered for that class before the date of record in order to receive financial aid for that class. If you are registered for a class that starts after the date of record, you must be registered for that class before the date of record in order to receive financial aid for that class.
