SPRING SEMESTER 2026

- JAN. 12** ▶ First Day of Spring Term
- FEB. 2** ▶ **Date of Record*** Second semester financial aid will be adjusted based on the number of credits student is enrolled in on this date.
- FEB. 9** ▶ Spring Financial Aid Book Deferment Ends
- FEB. 19** ▶ **Second Semester Disbursement** of Grants and Direct Subsidized and Unsubsidized Loans
- MAR. 6** ▶ **Registration for 8-week classes starting on March 16 closes at 4:00 p.m.**
- MAR. 28** ▶ **No Title IV Financial Aid Repayment** for Most Students AFTER This Date

* **THE PAYMENT OF FINANCIAL AID** is based on the number of credits enrolled as of the date of record. If you add any classes after the date of record, your financial aid eligibility will not increase. If you are on a waiting list for a class, then you must be off the waiting list and registered for that class before the date of record in order to receive financial aid for that class. If you are registered for a class that starts after the date of record, you must be registered for that class before the date of record in order to receive financial aid for that class.
